3. PRESIDENT'S REPORT, including the financial report.

As President, John Stanway began with highlighting CHA's growth in membership. New members Albury Wodonga Health joined in 2022-23 and Ipswich, Mackay Base, and the CEC NSW, as of September 2023. He then outlined key activities regarding each of the following strategic priorities:

Facilitating child, young person, and family centred care

- Paediatric Patient Reported Experience Measure (pPREMS) Development 6 member hospitals contributing with data analysis phase pending.
- Many effective strategies for partnering with children, young people and their families shared within the CHA community including: Planetree, MMF, Listen Carefully Project

Networking to share excellence and innovation.

- 15 dedicated networks for CHA members, 13 dedicated networks for leaders at children's hospitals
- 52+ meetings hosted with 2460+ participants.
- CHA connects over 4500+ paediatric professionals with 530+ new accounts in CHA member community.

Enhancing value through benchmarking

- New dashboards including variations in ALOS, high demand diagnoses, emergency care access, and access and outcomes for Aboriginal children and families.
- Improving Value in Healthcare Series

Strengthening the Safety & Quality of Children's Healthcare

- Focus on initiatives improving outcomes for eating disorders and supporting patients with complex mental health needs.
- National Paediatric Medicines Forum evaluate clinical efficacy and cost effectiveness of in scope high-cost medications to support safe, equitable and evidence-based prescribing & use.

Advocating for a healthy sustainable future

• Sharing of initiatives across CHA network to minimise carbon emissions in public hospitals.

Lastly, he gave an overview of the Auditor's report. Key highlights include:

- CHA has had strong membership renewal with 93% retention of member services.
- There was a modest surplus of \$15979 in the last financial year.
- CHA experienced increased income and costs due to delivering the MMF training.

The President thanked CHA members, the CHA team, and the board of directors with special thanks to outgoing directors Emma Maddren, Carola Wittekind, and Sean Turner.
